- I understand Club property is leased from a working timber operation, that logging and other activities will be ongoing throughout the property, and that occasionally I may need to adjust my stand location.
- I understand any guest the Club permits me to bring onto Club property must have a **2024** notarized Club Release form on file with management, that any guest hunter I bring onto Club Property will cost me \$50 per day (\$25 per half day), and that any guest hunter taking an antlered buck of any size, anywhere on the club, will incur a **\$400 buck fee**, plus applicable main club fines. I understand and agree that it is my responsibility to pay all fines that my guest refuses to pay.
- I understand I must attend at least one workday each year or pay \$250 in lieu thereof before being allowed to hunt on Club property.
- I understand I must hunt a minimum of three days during deer season or forfeit my opportunity to renew club membership next year.
- I have read and understand the 2024-2025 Club rules. I will abide by the rules while on Club property. I acknowledge it is my responsibility to pay all Club fines that I, my child, or my guest are assessed no later than 30 calendar days from the date of occurrence, and that I can't hunt until all fines are paid. I agree to have a current signed dues card in my possession whenever on Club property. I understand violation of any club rule makes me subject to expulsion from the Club without a refund of club dues.
