RELEASE AND WAIVER OF LIABILITY, INDEMNITY AND HOLD HARMLESS AGREEMENT

The Undersigned understands that the Property is used primarily by Howell for business purposes and by The Club as a hunting club and the Undersigned understands and assumes all of the risks associated with participation in the activities of a hunting club; including, but not limited to death, injury to person and injury/damage to personal property. The Undersigned understands that he/she undertakes the risks of being injured on the Property and/or having his/her property damaged, either by negligent or non-negligent behavior of others and/or the condition of the Property; including, but not limited to: The Club and Howell. Understanding the risks of using the Property and The Club, the Undersigned, for valuable consideration, the sufficiency of which is acknowledged, on behalf of him/her, his/her heirs, and assigns, hereby releases The Club and Howell, their subsidiaries, agents, directors, officers, representatives, employees, contractors, members, invitees, licensees, and guests, waives all claims against them, and agrees to indemnify and hold them harmless from any and all liability hereafter arising on account of damage, injury to person and/or death of the Undersigned or any minor child the Undersigned brings upon the Property, and/or damage or injury to his/her personal property RESULTING FROM NEGLIGENCE, RECKLESSNESS, OR THE BEHAVIOR OF ANY PERSON, HOWELL OR THE CLUB during the use of the Property by the Undersigned for recreational and sporting purposes. The Undersigned further agrees to follow all written rules and regulations of The Club and the laws of the Commonwealth of Virginia and the United States of America.

The Undersigned affirms that he/she has the right to use, carry and possess any firearm in their possession and has all required licenses to engage in shooting or hunting activity on the Property. The Undersigned acknowledges that he/she may only be present on the Property for any reason whatsoever when authorized as a current Member, accompanied by and in the presence of a current Member of the Club or with the express written permission of the Club or Howell.
